



Terms and Conditions of Use

1. Presentation of the Application

Welcome to the Mafy application, which enables you to track the growth, health and cleanliness of your dog.

These Terms and Conditions of Use (hereinafter referred to as the “Terms”) are intended to define the conditions of access to and use of the service.

Use of the application implies full acceptance of these Terms.
If you do not accept them, you are invited not to use the application.

2. Information about the Publisher

The application is published by a private individual:

3. Access to the Application and Authentication via Third-Party Services

Access to the Mafy application is provided exclusively through third-party authentication services, in particular Google and Apple.

3.1 Third-Party Authentication Services

By choosing to sign in via one of these services, you agree that electronic identification data strictly necessary for authentication purposes may be transmitted to Mafy by the relevant third-party provider, such as a unique identifier and, where applicable, an email address.

Mafy never has access to your Google or Apple login credentials or passwords.

3.2 Role and Responsibility of Third-Party Services

The authentication services provided by Google and Apple act as independent identity providers.

As such, they are solely responsible for:

- the management of your login credentials;
- the security and operation of their platforms.

Mafy has no control over the practices, privacy policies or terms of use of these third-party services.

Use of these services is subject to their own contractual terms, which you are invited to consult directly with the relevant providers.



3.3 Creation of the User Account

Upon your first login via a third-party authentication service, a user account is automatically created within the Mafy application based on the electronic identification data transmitted by the said service.

You are responsible for the accuracy of the information provided by the third-party service and for the use of your account.

3.4 Account Security

Any use of the application carried out via your Google or Apple account shall be deemed to have been carried out by you.

In the event of compromise, loss or fraudulent use of your third-party account, Mafy shall not be held liable for any consequences resulting from unauthorised access to the application.

4. Personal Data

As part of the use of the Mafy application, personal data are collected and processed in accordance with applicable regulations, in particular Regulation (EU) 2016/679 (General Data Protection Regulation – GDPR) and the amended French Data Protection Act.

4.1 Data Controller

The data controller for personal data processing is the publisher of the Mafy application, as identified in Article 2 of these Terms.

4.2 Privacy Policy

5. Use of the Services

The application offers the following services:

- monitoring of the dog's weight;
- monitoring of food quantities;
- monitoring of care to be provided;
- tracking of upcoming vaccinations;
- monitoring of cleanliness;
- creation of shared memories.

You agree to use these services solely for personal, non-commercial purposes. Any abusive use or use contrary to applicable laws and regulations is prohibited.



6. User Obligations

By using the application, you agree to:

- provide accurate information during registration;
- not use the application for fraudulent, unlawful or malicious purposes;
- not attempt to gain unauthorised access to the application's systems.

7. Intellectual Property

The application and all associated content (texts, logos, graphics, etc.) are protected by intellectual property rights.

You may not reproduce, distribute or exploit these elements without prior authorisation.

8. Publisher's Liability

The application is provided free of charge.

While reasonable efforts are made to ensure reliable service, Mafy does not guarantee that the application will be free from errors or technical issues.

The publisher shall not be held liable for:

- loss or alteration of user data;
- unauthorised access to the user's account resulting from compromised credentials;
- temporary or permanent interruptions of the service.

9. Notifications and Marketing Emails

Upon registration, you agree to receive notifications related to the use of the services (vaccination tracking, cleanliness reminders, etc.).

Where you have given explicit consent, you may also receive marketing emails or special offers.

You may withdraw your consent at any time by using the unsubscribe link included in emails or by contacting contact@mafy.app.

10. Modification of the Terms

These Terms may be modified at any time.

Any changes will be communicated via the application or by email.

Continued use of the application following such changes constitutes acceptance of the updated Terms.



11. Termination and Account Deletion

You may request deletion of your account at any time by contacting contact@mafy.app. Your personal data will then be deleted in accordance with the Privacy Policy, unless legal obligations require longer retention.

The publisher reserves the right to suspend or delete an account in the event of non-compliance with these Terms or fraudulent use of the application.

12. Applicable Law and Jurisdiction

These Terms are governed by French law.

In the event of a dispute relating to use of the application, the parties shall endeavour to resolve the matter amicably.

Failing such resolution, the French courts shall have jurisdiction.
